

A pulse discharge of <sup>137</sup>Cs from K-159 may cause concentrations in muscle of cod up to 63 and 123 Bq/kg fresh weight in the near-surface and near-bottom layer, respectively.

199 GammaProteobacteria as a potential bioindicator of a multiple contamination by polycyclic aromatic hydrocarbons (PAHs) in agricultural soils

Naturally occurring MnO2 may contribute significantly to the attenuation of nonylphenol and octylphenol in soil, water and sediment.

Ammonia from a poultry unit has upwind impacts, exceeding critical levels 800 m and critical loads 2.8 km upwind, and increasing biomass and tissue N of dune grassland species.

Within a population where rice is a staple food, maternal blood may be an appropriate biomarker for prenatal methylmercury exposure.

**Effects of a three-year exposure to ambient ozone on biomass allocation in poplar using ethylenediurea** Y. Hoshika, F. Pecori, I. Conese, T. Bardelli, E. Marchi, W.J. Manning, O. Badea, E. Paoletti

Ozone reduced allocation of biomass to leaves, roots and lateral branches, but did not affect stem length and diameter.

Environmental Pb contamination in the Mount Isa urban area is derived primarily from smelter emissions and local fugitive mining sources and not natural in situ surface mineralization.

Through careful selection of literature data, structure–property estimation and adjustment, key properties of 209 PBDE congeners are estimated with internal consistency.

Concentrations assumed as protective in chemical regulation cause adverse effects in three fundamental ecosystem functions.

This review fulfils the lack of knowledge regarding the use of lichens and aquatic mosses as biomonitors of POPs, providing a set of guidelines to be followed.

The phytotoxicity database does not support toxicity predictions for most oils and dispersants.

Eight steroid hormones were found in biogas digestate byproduct in the ng  $g^{-1}$  dm levels. Anaerobic digestion processes do not completely remove steroid hormones from organic waste residues.
